Description of Session Formats

Session Format

Specific Issues of Discussion

Since technology cuts across multiple sectors, privacy and data protection are both vertical (across sectors) and horizontal (across the size of the business) in nature. This will challenge the future Data Protection Board as it will have to design and enforce standards to realise a fundamental right across various contexts and sectors.

The Digital Personal Data Protection Act 2023 (DPDPA) is not India's first effort to regulate personal data. Various laws and regulations directly or indirectly apply to the handling of personal data in India. This would include, for example, a draft bill on DNA technology, health data retention and management, etc. Given that the DPDPA may prevail over other existing and proposed laws in case of inconsistency, this

jurisdictional precedence is easier said than done in the Indian regulatory landscape.

Therefore, as contending with inter-regulatory harmonisation and coordination problems would be a major concern, this session will discuss the specific challenges of inter-regulatory harmonisation and cooperation, why they will arise, and how to mitigate them as we move forward.

Describe the Relevance of Your Session to Theme

The lack of harmonisation of laws causes vague interpretation of these provisions and risks sub-optimal approaches to standard-setting and regulatory arbitrage that rely on discretion rather than a uniform application of the law. Therefore, this session will discuss the possible clashing scopes and provisions that are prone to multiple interpretations within various data regulations in India. By doing this, the session would try to identify emerging challenges towards harmonising digital laws in India and discuss means and strategies.

- (1) Kamesh Shekar: Kamesh Shekar leads the Privacy and Data Governance vertical and co-leads the Artificial Intelligence vertical at The Dialogue. He also serves as a Youth Ambassador for The Internet Society. With an educational background, including a PGP in public policy from the Takshashila Institution, an MA in media and cultural studies, and a BA in social sciences from the Tata Institute of Social Sciences. - (5) Justice BN Srikrishna: Justice B.N. Srikrishna is a distinguished former judge of the Supreme Court of India, renowned for his significant contributions to Indian jurisprudence. He served as a Supreme Court judge, during which he was involved in landmark judgments and pivotal legal reforms. Post-retirement, Justice Srikrishna has continued to impact the legal field as a chairperson of various committees, including those related to data protection and financial sector reforms.
